

What is the purpose of a strong brand: to attract customers, to build loyalty, to motivate staff? All true, but for a commercial brand at least, the first answer must always be 'to make money'.

Huge investments are made in the design, launch, and ongoing promotion of brands. Given their potential financial value, this makes sense. Unfortunately, most organisations fail to go beyond that, missing huge opportunities to effectively make use of what are often their most important assets. Monitoring of brand performance should be the next step, but is often sporadic. Where it does take place, it frequently lacks financial rigour and is heavily reliant on qualitative measures, poorly understood by non-marketers.

As a result, marketing teams struggle to communicate the value of their work and boards then underestimate the significance of their brands to the business. Sceptical finance teams, unconvinced by what they perceive as marketing mumbo jumbo, may fail to agree necessary investments. What marketing spend there is, can end up poorly directed as marketers are left to operate with insufficient financial guidance or accountability. The end result can be a slow but steady downward spiral of poor communication, wasted resources, and a negative impact on the bottom line.

Executive Summary.



AMD has been named the fastest-growing semiconductor brand of 2022. The brand has seen an impressive growth of 122% over the past year to US\$6.1 billion, up from US\$2.7 billion in 2021.

Every year, Brand Finance puts 5,000 of the biggest brands to the test, and publishes nearly 100 reports, ranking brands across all sectors and countries. For the first time, the world's top 20 most valuable and strongest semiconductor brands are included in a separate industry ranking - the Brand Finance Semiconductors 20 2022.

AMD has seen the highest rate of growth among the world's top 20 semiconductor brands included in the ranking, more than doubling in brand value in just a year. When considering a broader two-year timeframe of the span of the COVID-19 pandemic, AMD's brand value has grown by an eyewatering 318%. This growth can be attributed to focusing on the mobile and server segments and expanding to the gaming segment. AMD has invested in the potential of the gaming industry by forging strategic partnerships with Xbox and PlayStation.

The CEO of the semiconductor industry's star performer, Dr. Lisa Su, has also been recognized in the Brand Finance Brand Guardianship Index 2022 as the highest ranked woman, claiming 10th place overall. The Index ranks the world's top 250 chief executives according to how well they manage and grow their company's brand. The ranking is informed by the results of an original survey of over 1,000 market analysts and journalists. Dr. Su's leadership of a tech company is unfortunately a rarity, with most being run by male CEOs. This is reflected in the ranking, with only five female CEOs in the top 100.

Ultimately, the role of a brand quardian is to build brand and business value. Our ranking recognises those who are building business value in a sustainable manner, by balancing the needs of all stakeholders employees, investors, and the wider society.


Intel ranks #1 in the semiconductor sector

Although AMD has seen the highest rate of growth among the top 20 semiconductor brands included in the ranking, Intel ranks as the industry's most valuable brand globally, with a brand value of US\$25.6 billion. The brand has recorded a drop in value of 20% since last year, as its operations have been impacted by supply chain issues and chip shortages at the end of 2021 which caused a loss of market share compared to competitors. Although there have been setbacks induced by the pandemic, Intel newly released its 12th generation processor series Alder Lake which aims to achieve better performance for high intensity tasks such as gaming and video editing.

US brands dominate semiconductor ranking with 7 out of the top 10

Despite the pandemic, the semiconductor industry has set a new annual record for sales by increasing production and distribution globally. The ranking includes seven American semiconductor brands in the top 10 alone: Intel, Nvidia, Qualcomm, Broadcom, Micron Technology, AMD, and Texas Instruments.

Brand Value Change 2021-2022 (%)




The semiconductor industry has created a tremendous, lasting impact on society and our daily lives. As technology advances, there is a rising demand from different sectors such as automotive brands that manufacture electric vehicles which drive market demand significantly. The semiconductor market is expected to grow substantially owing to the rising investment by the market players to expand the sector.

In 2021, unit production of semiconductors has doubled since the previous year and is expecting growth to fulfil demands to execute chip needs for new innovations in artificial intelligence, quantum computing and 5G smartphones. The US government has proposed to devote a budget of US\$50 billion towards semiconductor investment and research to promote domestic manufacturing as a priority.

Nvidia shines as the strongest semiconductor brand


Apart from calculating brand value, Brand Finance also determines the relative strength of brands through a balanced scorecard of metrics evaluating

marketing investment, stakeholder equity, and business performance. Certified by ISO 20671, Brand Finance's assessment of stakeholder equity incorporates original market research data from over 100,000 respondents in more than 35 countries and across nearly 30 sectors.

Although Intel is the industry's most valuable brand, a fellow American brand Nvidia is the strongest semiconductor brand in the world with a Brand Strength Index (BSI) score of 83.6 out of 100. As an expert in the field of Al chips and graphics, Nvidia has forecasted a boost in revenue after Facebook's rebrand to Meta with the aim of supporting applications by creating a virtual reality metaverse.



TOP 10 FASTEST GROWING AMERICAN BRAND

Interview with John Taylor.



John Taylor Chief Marketing Officer, **AMD**

AMD once again features in the top 10 fastest growing brands in the US (122% increase YoY). To what do you attribute the incredible growth in 2021?

We have leadership products across our focus markets which helps fuel business momentum and growth. And those high-performance computing markets where we are focused - from cloud services to PCs to game consoles and graphics are in high demand. We complemented this in 2021 with investments in building awareness and equity for the AMD corporate brand through multiple high impact campaigns.

Brand Finance market research also reveals that AMD exhibits high levels of customer recommendation whilst perceptions of overall reputation have also increased over 12 months. Do you think the brand has strong momentum within the consumer segment?

We have had strong growth in both consumer computing and graphics and expect this to continue with ongoing great products and marketing. For example, AMD is the brand powering all forms of gaming (e.g., PC, console, cloud, and handheld) and our partnerships with Tesla and Samsung are expanding our reach further, to even more consumers.

AMD has experienced phenomenal growth in both business and brand value over the last 5 years and strategic mergers such as the deal announced with XILINX in 2020 have contributed significantly to this. What do you see as key growth opportunities for the brand over the next 5 years?

Our vision is for AMD to lead in high performance computing for the most important markets today and tomorrow. Thus, we see significant opportunities to continue to grow the AMD brand. We believe the Xilinx acquisition will contribute significantly in new and meaningful ways, evolving our company and vision, developing new technologies, introducing us to new markets, and partnering with new customers.

What are the core values at the heart of AMD and how do you see these helping the brand grow and distinguish itself from key competitors such as

AMD is all about building great products, deepening customer relationships, and getting consistently better at everything we do. As such, we are developing an inclusive brand that relies on our partners, as much as they rely on us, with the belief that the best progress is the progress we make together.

Intel has dropped 20 places in our rankings from 18th to 38th whilst AMD has climbed from 290th to 147th. Do you foresee this gap closing even more in the future?

We are focused on strengthening our brand, expanding our communities, and building deep industry partnerships. All enabled by our industry leading technology roadmap. We are truly excited about what is to come.

Brand Valuation Methodology.

Definition of Brand

Brand is defined as a marketing-related intangible asset including, but not limited to, names, terms, signs, symbols, logos, and designs, intended to identify goods, services, or entities, creating distinctive images and associations in the minds of stakeholders, thereby generating economic benefits.

Brand Value

Brand value refers to the present value of earnings specifically related to brand reputation. Organisations own and control these earnings by owning trademark rights.

All brand valuation methodologies are essentially trying to identify this, although the approach and assumptions differ. As a result published brand values can be different.

These differences are similar to the way equity analysts provide business valuations that are different to one another. The only way you find out the "real" value is by looking at what people really pay.

As a result, Brand Finance always incorporates a review of what users of brands actually pay for the use of brands in the form of brand royalty agreements, which are found in more or less every sector in the world.

This is sometimes known as the "Royalty Relief" methodology and is by far the most widely used approach for brand valuations since it is grounded in reality.

It is the basis for a public rankings but we always augment it with a real understanding of people's perceptions and their effects on demand – from our database of market research on over 3000 brands in over 30 markets

Brand Impact

We review what brands already pay in royalty agreements. This is augmented by an analysis of how brands impact profitability in the sector versus generic brands.

> This results in a range of possible royalties that could be charged in the sector for brands (for example a range of 0% to 2% of revenue)

Brand Strength

We adjust the rate higher or lower for brands by analysing Brand Strength. We analyse brand strength by looking at three core pillars: "Inputs" which are activities supporting the future strength of the brand; "Equity" which are real current perceptions sourced from our market research and other data partners; "Output" which are brand-related performance measures such as market share.



Each brand is assigned a Brand Strength Index (BSI) score out of 100, which feeds into the brand value calculation. Based on the score, each brand is assigned a corresponding Brand Rating up to AAA+ in a format similar to a credit rating.



Brand Impact × **Brand Strength**



The BSI score is applied to the royalty range to arrive at a royalty rate. For example, if the royalty range in a sector is 0-5% and a brand has a BSI score of 80 out of 100, then an appropriate royalty rate for the use of this brand in the given sector will be 4%.

Forecast Brand Value Calculation

We determine brand-specific revenues as a proportion of parent company revenues attributable to the brand in question and forecast those revenues by analysing historic revenues, equity analyst forecasts, and economic growth rates.



We then apply the royalty rate to the forecast revenues to derive brand revenues and apply the relevant valuation assumptions to arrive at a discounted, posttax present value which equals the brand value.

Brand Strength.

Brand Strength

Analytical rigour and transparency are at the heart of our approach to brand measurement at Brand Finance. Therefore, in order to adequately understand the strength of brands we conduct a structured, quantitative review of data that reflect the 'Brand Value Chain' of brand-building activities, leading to brand awareness, perceptions and onwards to brand-influenced customer behaviour.

To manage the 'Brand Value Chain' process effectively we create and use the "Brand Strength Index" (BSI). This index is essentially a modified Balanced Scorecard split between the three core pillars of the 'Brand Value Chain': Brand Inputs, Brand Equity and **Brand Performance.**

Marketing Strength Index Investment Stakeholder **Equity** Brand **Business** Performance

Widely recognised factors deployed by marketers to create brand loyalty and market share.

Perceptions of the brand among different stakeholder groups, with customers being the most important.

Quantitative market and financial measures representing the success of the brand in achieving price and volume premium.



Attribute Selection and Weighting

Although we follow a general structure incorporating the three pillars (Brand Inputs, Brand Equity and Brand Performance), the attributes included are different depending on the sector. A brand strength index for a luxury apparel brand will differ in structure from an index designed for a telecommunications brand. An index for luxury apparel brand may emphasize the exclusiveness, word of mouth recommendation, and price premium, whereas an index for a telecommunications company may emphasis customer service and ARPU as important metrics.

These attributes are weighted according to their perceived importance in driving the following pillar: Brand Investment measures in driving Brand Equity; Brand Equity measures for Brand-Related Business Performance measures; and finally the relevance of Brand-Related Business Performance measures for driving business value.

Data Collection

Brand's ability to influence purchase depends primarily on people's perceptions. Therefore, the majority of the Brand Strength Index is derived from Brand Finance's proprietary Global Brand Equity Research Monitor research, a quantitative study of a sample of over 100,000 people from the general public on their perceptions of over 4,000 brands in over 25 sectors and 37 countries.



However, at Brand Finance we also believe that there are other measures that can be used to fill gaps that survey research may not capture. These include total investment levels - for example in marketing, R&D, innovation expenditure, that can a better guide to future performance than surveys. They also include online measures such as ratings by review sites and social media engagement that can give a more granular understanding of marketing effectiveness. Finally they also include real behaviour - for example net additions, customer churn and market share, to overcome the tendency for surveys to incorporate intended behaviour rather than real.

Over a period of 3 to 4 months each year, we collect all this data across all the brands in our study in order to accurately measure their comparative strength.

Benchmarking and Final Scoring



In order to convert raw data in to scores out of 10 that are comparable between attributes within the scorecard, we then have to benchmark each attribute. We do this by reviewing the distribution of the underlying data and creating a floor and ceiling based on that distribution.

Each brand is assigned a Brand Strength Index (BSI) score out of 100, which feeds into the brand value calculation. Based on the score, each brand is assigned a corresponding rating up to AAA+ in a format similar to a credit rating.

Analysing the three brand strength measures helps inform managers of a brand's potential for future success.



Highlights from the Global Brand Equity Monitor.

Brand Finance's proprietary market research provides a robust assessment of brand health on key equity measures, allowing comparison both within and across product and service categories. Benchmarking against brands outside your sector is especially helpful in assessing the real strength of brand - not just the 'best of a bad bunch' in a category where brands are generally weaker.

What makes a brand great?

Amazon is undoubtedly one of the world's strongest brands, one of just a handful achieving the highest AAA+ rating. It has an extremely strong brand funnel, with near-universal familiarity, and consideration, and while its reputation score is not best-in-class, it is stronger than many of its critics might think.

Every strong brand has its own winning formula, and our research highlights Amazon's particular advantages. Top of that list is the outstanding value which shoppers believe Amazon delivers. Amazon ranks on this measure in big markets such as Brazil, USA, UK, and is #1 among retailers in many more. Value has always been a big driver of consumer behaviour, but Amazon also delivers a slick shopping experience ("excellent website/apps"), and this powerful combination is irresistible for many consumers, even those who question Amazon's values and broader corporate reputation.

Does brand purpose deliver?

Argument rages among CMOs and marketing gurus over this issue. The jury is out - our data suggests that being seen to "care about the wider community" does correlate somewhat with higher Consideration levels, and is an asset particularly for local favourites such as Jio (India) or Bunnings (Australia). But brands like McDonald's and Nike (as well as Amazon) are liked and desired despite somewhat moderate reputations on sustainability and values





Cool brands get talked about, and word-of-mouth (WOM) is another key asset some brands possess. It has proven impact on brand growth, hence WOM's inclusion in our Brand Strength Index model.

In an absolute sense, big brands get talked about a lot more than small ones – their sheer mass presence and relevance ensures that. But deeper analysis reveals a number of challenger brands who look set to profit from above-expectation WOM levels and positive consumer sentiment. Keep an eye on Tim Horton's in Spain, Peros Garment Factory (Canada), SAIC in, yes, the USA and **iinet** in Singapore.


